The US Wild Horse and Burro Association is proud to announce that our trainers, as Bureau of Land Management volunteers, are participating in a BLM pilot program "mini adoption" at Ricks Saddle Shop Cream Ridge, New Jersey store, 282 Rt. 539 Cream Ridge, N.J. There will be ten to fifteen gentled and halter trained mustangs available for adoption. The adoption will be Saturday, May 2nd, 2009, between 9 a.m. and 5 p.m. There will be employees of the Bureau of Land Management's "Adopt a Wild Horse or Burro Program" on-site to process applications for potential adopters.

The following day, Sunday May 3rd, 2009, we will be participating in the Hunterdon County Horse Expo at South County Park, Route 179 at Route 202, Ringoes, New Jersey. The hours are 9 a.m. to 4 p.m. We will have a booth at the expo with information about our organization and the mustangs. Employees of the Bureau of Land Management will also be there with us. We will have many of our own mustangs, as well as a burro and we will be participating in the daily parade of breeds in the outdoor arena. Last year we had the largest breed representation at the expo!

The expo has much to offer. There are many booths, displays, and vendors representing all aspects of the horse and farming community. Food and beverages are available at the many stands on the grounds.
